Conduct

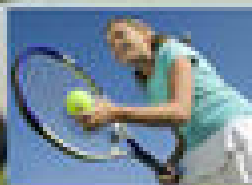

Children

- * The Sunday summer opening hours are only applicable if there is not a private function on the club premises. If there is a private function, the club will be open for members at 8pm.

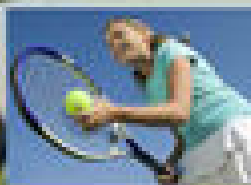
Annual General Meeting
